The following questions were submitted by the Susan B. Anthony Recovery Center on July 17, 2014:

Question 1: What is the proposed Budget period -- 1 year?
Answer 1: Respondents should submit a budget representing costs for one 12-month period.
Question 2: What is the proposed starting date and ending date?
Answer 2: BBHC is seeking information on the availability of Peer Recovery Support Services. Information may be used to award future contract(s).
Question 3: Regarding B: Program Design/Description - "The respondent shall include any agreements" - assuming these are included as attachments, please confirm that these are not included in the page limit.
Answer 3: Agreements are not counted in the page limit.
Question 4: Regarding C: Staffing - should we include Program related resumes, or all management resumes?
Answer 4: Respondents should include resumes for staff that support its ability and/or experience in providing Peer Recovery Support Services.

Question 5: Does BBHC intend to fund more than one provider under this RFI?

Question 6: Is this a cost-reimbursement contract or a Unit Rate? a. If Unit Rate, are the Unit rates the same as “Recovery Support” OCA (individual and Group) as indicated in 65E-14?

Question 7: What is the Service and Audit Documentation for this Cost Center?

Question 8: Is a Clinical Diagnosis required for eligibility? (<i>The “Recovery Support” OCA Does require this as Service Documentation</i>)
Answer 8: BBHC seeks information from respondents to serve individuals who have a severe and persistent mental illness and/or co-occurring substance abuse disorder diagnosis.
